What Will Happen on February 14?

- Arena officials have prepared a green room for us so we can renew friendships and enjoy a pre-game brunch prior to the DePaul-Seton Hall game at the Prudential Center. We will also hear from professional broadcasters – including Seton Hall and New York Mets broadcasting great Gary Cohen!

What Should I Wear?

- Respectable “school” clothes. Jeans, sweatshirts, sneakers are **STRONGLY** discouraged.

When/How Should I Get to the Arena?

- Campers will meet in the lobby at the southwest corner of Prudential Center on Lafayette Street (adjacent to the Pru Center parking garage) at **EXACTLY** 10:30 a.m.
- There are various pay parking lots within a block of the arena including the garage on Lafayette Street and several surface lots surrounding the arena, with varying pricing.
- NJ Transit and PATH trains are convenient methods to reach Prudential Center. Take the train to Newark Penn Station and walk three blocks west to the arena, which is located on Mulberry Street between Edison Place and Lafayette Streets.
- It is suggested that family members who will attend the game drop-off campers and return closer to 12:00 noon game time. The gates open to the general public at 11:00 a.m. We will forward a list of area restaurant partners closer to the event, to provide pre-game dining options in Newark.
- Camper pick-up for family members **NOT** attending the game is the southwest corner of the arena (near the parking garage) on Lafayette Street.
